
- **Safe and healthy working conditions including adequate facilities and arrangements for employee's welfare.**

ENVIRONMENTAL POLICY STATEMENT


InterCeil Limited recognises the importance of environmental management and is committed to operating its business responsibly.


- We aim to deliver our service efficiently and effectively in compliance with the clients specifications
